Finance of America Reverse is Finalist in Wealth Management Industry "Wealthies" Awards

Company also Honored as Finalist in 2022 ThinkAdvisor Luminaries Awards

The final round of judging will now begin, with the winners in each category revealed on September 8, 2022, at the grand gala and awards ceremony taking place at the Ziegfeld Ballroom in New York City.

"FAR's solutions help unlock the power of an individual's home so that they can enjoy retirement on their terms with family, friends, and the things they cherish most in life," explained <u>Marie Swift</u>, president and CEO of Impact Communications, Inc., in her nomination narrative. THE LUMINARIES COMPETITION

Swift, who has been serving as a strategic consultant to Brown and FAR's Retirement Strategies Division, also nominated Finance of America's <u>CARES program</u> (CARES) in the Community Impact category for this year's Luminaries awards. The CARES program, which made the list of finalists, was in 2021 able to provide nearly \$600,000 to more than 120 community-based nonprofit organizations across the nation. From these grants, more than 34,000 people were served in the areas of youth and human services as well as veterans affairs.

"The company focused on this approach for a variety of reasons," Swift said in her nomination narrative.
