Data is provided by each firm, mostly from numbers and information published on forms they submit to the SEC. Each advisor is then ranked alongside their participating peers.

In addition to Financial Advisor Magazine’s list of top RIAs, the publication also reported on the ways financial advisors are adapting to the COVID-19 pandemic, including the adoption of advanced technologies to maintain personable client communications.
